Data on half-day and full-day Kindergarten enrollment, and students with limited English proficiency (LEP) was provided by the NJ Dept. of Education and is based on the 2011-2012 school year. State totals may include Charter School enrollments. The number of children receiving early intervention services was compiled in the NJ Early Intervention County Performance and Determination Report prepared by the NJ Dept. of Health, Division of Family Health Services and reports the number of children with active IEPs as of December 2010. The number of children classified as Special Education students was reported by the NJ Dept. of Education, Office of Special Education Programs as of Oct 15, 2011. The percent of students passing the 4th Grade Achievement Test during school year 2010-2011 was obtained from the NJ Dept. of Education and includes charter schools as well as public schools.
