CCDBG The Child Care Development Block Grant

Meeting the basic health and safety needs of all children sets the stage for positive child outcomes. The Child Care Development Block Grant (CCDBG) is the primary federal grant program that provides child care assistance for families and funds child care quality initiatives. In November 2014, Congress passed bipartisan legislation to promote the safety of children in child care (P.L. 113 - 186). These baseline safety and quality measures are to improve the quality of all early care and education programs.

To meet these requirements, the State of New Jersey has issued the following provisions that must be met by all child care programs that receive child care subsidy funds. This includes all child care centers, Family Child Care providers and Summer Camps which receive child care subsidy funds.

All staff working in center-based programs must complete training to meet the CCDBG authorization requirements under the Federal Child Care Development Block Grant (CCDBG) Reauthorization Act of 2014 to increase the health and safety requirements for all child care and early learning programs that accept child care subsidies.

Improve Your Child Care Skills

You will be exposed to trainings about early childhood development, positive methods of discipline, guidelines on health and nutrition, play and learning activities, business management and communicating with parents.

Obtain Contacts with Parents Seeking Family Child Care

When you become registered, you enroll in our child care network database. This helps you connect with parents seeking child care in your neighborhood.

Cover Food Costs for Children

As a Registered Family Child Care provider, you are eligible to participate in the Child and Adult Care Food Program (CACFP) and receive reimbursement for part of the cost of meals served to children in your care.

Professional Image when Marketing to Potential Families

Becoming a Registered Family Child Care provider is optional in New Jersey. Going through the process to become a Registered provider and maintain Registration is a testament to your commitment to professionalism and providing quality child care!

QUALITY RATING IMPROVEMENT SYSTEM



Grow NJ Kids is New Jersey's newly adopted Quality Rating and Improvement System. It was created to provide a universal standard of quality for all early care and education programs (Head Start, Child Care, Family Child Care, Public Schools, etc.) throughout New Jersey. The goal is to create a system that encourages ongoing enhancement for a safe, healthy, and high-quality child care experience.

Grow NJ Kids gives child care and early learning programs resources to assess and enhance the quality of care they are providing for New Jersey's young children. This initiative also focuses on educating parents with information that allows them to evaluate the quality of programs and make the best choices for their child.

Participants enrolled in Grow NJ Kids have exclusive access to free training for staff. Participants also receive free, on-site quality improvement technical assistance visits, access to information on the most current evidence-based practices, a clear roadmap for improving quality, and an assessment tool to review their program.

Child Care Resources of Monmouth County supports Grow NJ Kids for early childhood providers throughout the county. We provide center-based and family child care providers with support in demonstrating and working to enhance the quality of experiences for children and families in their care.

CDA Child Development Associate

Wondering how you can advance your career in early childhood education?

The Child Development Associate (CDA) Credential™ is the a widely recognized credential in early childhood education and is a key stepping stone on the path of career advancement. The Child Development Associate (CDA) Credential™ is based on a core set of competency standards, which guide early care professionals as they work toward becoming qualified teachers of young children. You can get your CDA with Child Care Resources!

The CDA program at Child Care Resources offers a cost effective, hybrid learning approach on a user-friendly online platform. The required 120 professional development hours are available in a self-paced, online format and are combined with monthly, face-to-face coaching sessions. This hybrid approach allows for online learning to take place on your own time, while the in-person coaching sessions keep you on track to complete your portfolio and obtain your CDA in a year's time!



How does it work?

- 1) 120 hours of coursework. Offered online through Quorum with Child Care Resources. Subject area requirements are outlined by the CDA coach for simple navigation.
- 2) 480 hours of experience working with young children within 3 years of applying for the credential. You can work towards these hours while completing your coursework.
- 3) Prepare your CDA Professional Portfolio. You will do this with the help of your coach!
- 4) Participate in monthly coaching sessions: one session per month for two hours in-person at Child Care Resources' office.
- 5) After coursework is complete you will set up an in-class observation, take an exam, and apply for your CDA!!
