# Highlights of CCR in 2020: Working through this Pandemic together!

COVID responses in 2020 were facilitated by the public, private partnership with The NJ Department of Human Services, Division of Family Development, and Child Care Resources.



Child Care Resources always works closely with our programs and families to better understand your needs. Child care has come a long way through this pandemic. With your advocacy, endless input, and perseverance we have accomplished so much for our children through this everchanging storm! Here are some of the things that Child Care Resources has accomplished during the pandemic for your business, your families, and most importantly, the children in your care!

- Implemented emergency child care payments for essential workers and matched them to open child care programs for over 900 new families.
- Provided PPE to registered family child care providers (in the spring and fall of 2020)
- Implemented parent co-pay waivers and increased subsidy payments as part of the child care subsidy program
- Supported stabilization grants to family child care providers (in the spring and fall of 2020)
- Implement supplemental subsidy payments to providers to support re-opening and sustainability of providers
- Responded to questions related to tuition support for school-age child care (fall 2020)
- Establishment of a shared services alliance for family child care providers, which seeks to both support better business practices and an easy on-ramp to becoming a child care entrepreneur.
- Lead the online learning series, "Reimagine Child Care", reaching hundreds of child care providers across the state
- Facilitated weekly Director and teacher support Zoom calls

### CCDBG

### The Child Care Development Block Grant

Meeting the basic health and safety needs of all children sets the stage for positive child outcomes. The Child Care Development Block Grant (CCDBG) is the primary federal grant program that provides child care assistance for families and funds child care quality initiatives. In November 2014, Congress passed bipartisan legislation to promote the safety of children in child care (P.L. 113 - 186). These baseline safety and quality measures are to improve the quality of all early care and education programs.

To meet these requirements, the State of New Jersey has issued the following provisions that must be met by all child care programs that receive child care subsidy funds. This includes all child care centers, Family Child Care providers, and Summer Camps which receive child care subsidy funds.

All staff working in center-based programs must complete training to meet the CCDBG authorization requirements under the Federal Child Care Development Block Grant (CCDBG) Reauthorization Act of 2014 to increase the health and safety requirements for all child care and early learning programs that accept child care subsidies.

The Child Development Associate (CDA) Credential™ is a nationally recognized credential in early childhood education and is a key stepping stone on the path of career advancement. The Child Development Associate (CDA) Credential™ is based on a core set of competency standards, which guide early care professionals as they work toward becoming qualified teachers of young children. You can get your CDA with Child Care Resources!

The CDA program at Child Care Resources offers a cost effective, virtual learning approach on a user-friendly online platform. The required 120 professional development hours are available in a self-paced, online format and are combined with monthly, Zoom coaching sessions. This approach allows for online learning to take place on your own time, while the coaching sessions keep you on track to complete your portfolio and obtain your CDA in a year's time!

#### How does it work?

120 hours of coursework. Offered online through Quorum with Child Care Resources. Subject area requirements are outlined by the CDA coach for simple navigation. 480 hours of experience working with young children within 3 years of applying for the credential. You can work towards these hours while completing your coursework. Prepare your CDA Professional Portfolio. You will do this with the help of your coach! # New Jersey's Quality Rating Improvement System



Grow NJ Kids is New Jersey's Quality Rating and Improvement System. It was created to provide a universal standard of quality for all early care and education programs (Head Start, Child Care, Family Child Care, Public Schools, etc.) throughout New Jersey. The goal is to create a system that encourages ongoing enhancement for a safe, healthy, and high-quality child care experience.

Grow NJ Kids gives child care and early learning programs resources to assess and enhance the quality of care they are providing for New Jersey's young children. This initiative also focuses on educating parents with information that allows them to evaluate the quality of programs and make the best choices for their child.

Enrollment tells parents that your program is committed to quality improvement! Participants enrolled in Grow NJ Kids have exclusive access to free training for staff. Participants also receive free, on-site/virtual quality improvement technical assistance visits, access to information on the most current evidence- based practices, a clear roadmap for improving quality, and an assessment tool to review their program.

Child Care Resources of Monmouth County supports Grow NJ Kids for early childhood providers throughout the county. We provide center- based and family child care providers with support in demonstrating and working to enhance quality of experiences for children and families in their care.
